Mandarin Athletic Association (MAA) Greenland Park - 11808 Fayal Drive

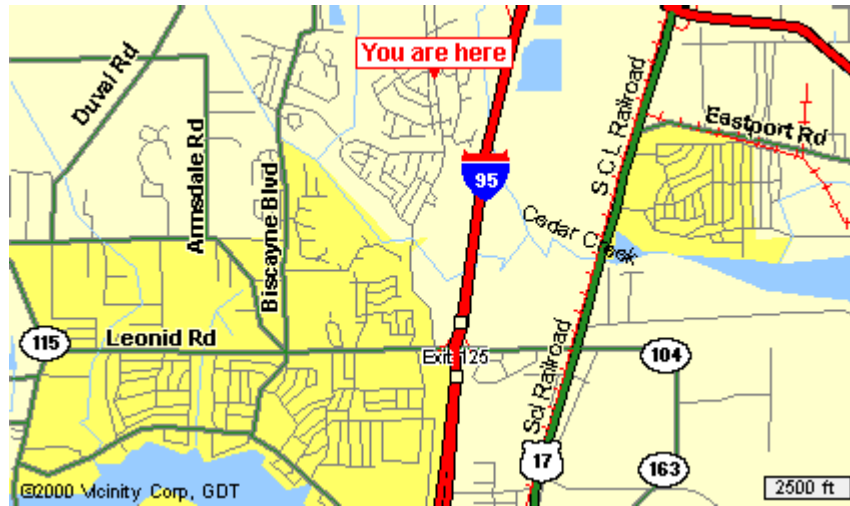


South on I-95 to US 1 South (Phillips Highway), turn right (west) onto Greenland Road, proceed to Fayal Road & turn left (south) onto Fayal Road. The road will dead end at the park.

I-295 to Old St. Augustine Road (exit #1), turn south onto Old St. Augustine Road and proceed to Greenland Road, turn left (east) onto Greenland Road, pass Mandarin High School to Fayal Road (approximately 4 miles), turn right onto Fayal Road and the road will dead end at the park

(aka Highlands Little League Park)

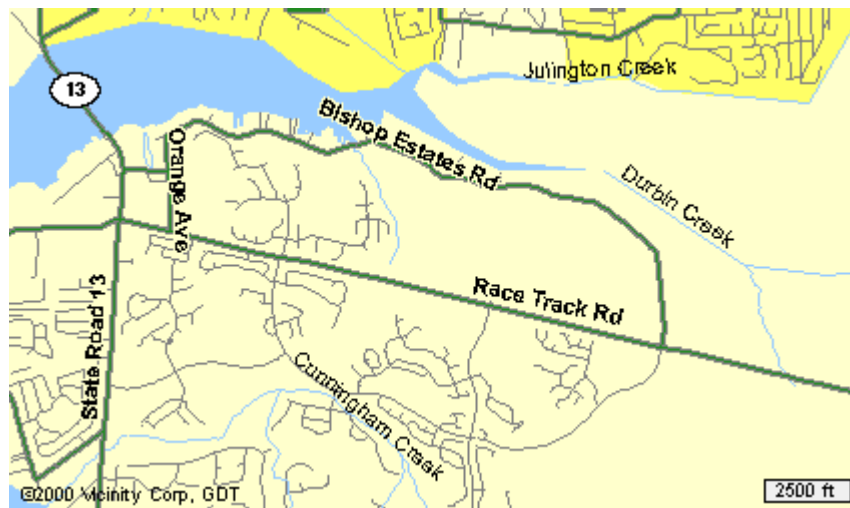


I-95 north to Dunn Avenue, turn west onto Dunn Avenue and go to Harts Road (Western Sizzlin's on the corner), turn right (north) onto Harts Road and follow road all the way to the end, the park will be on the right (east) side of the road

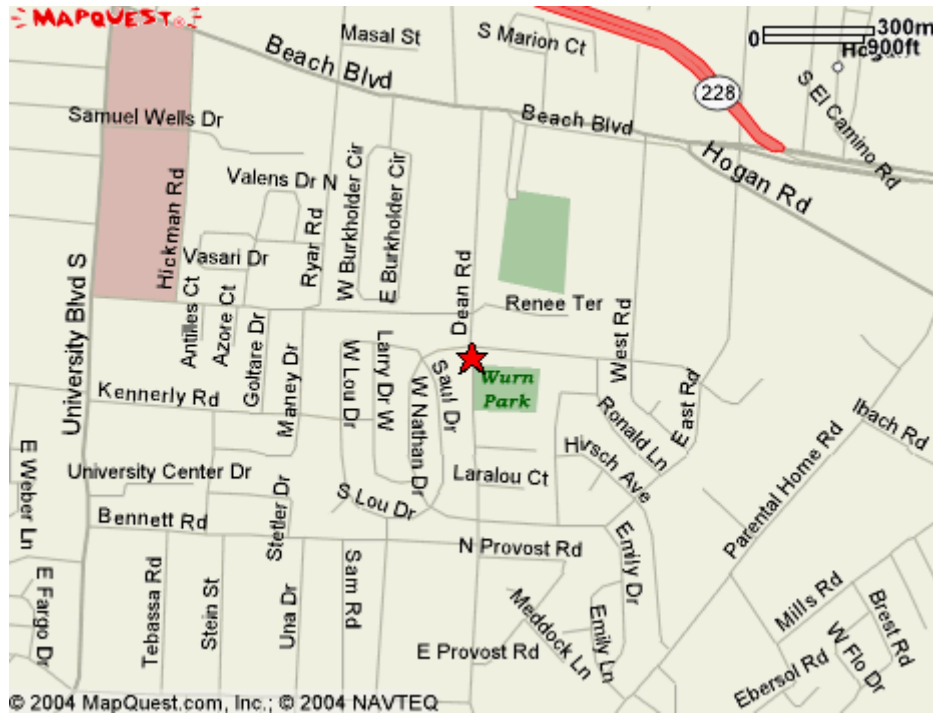

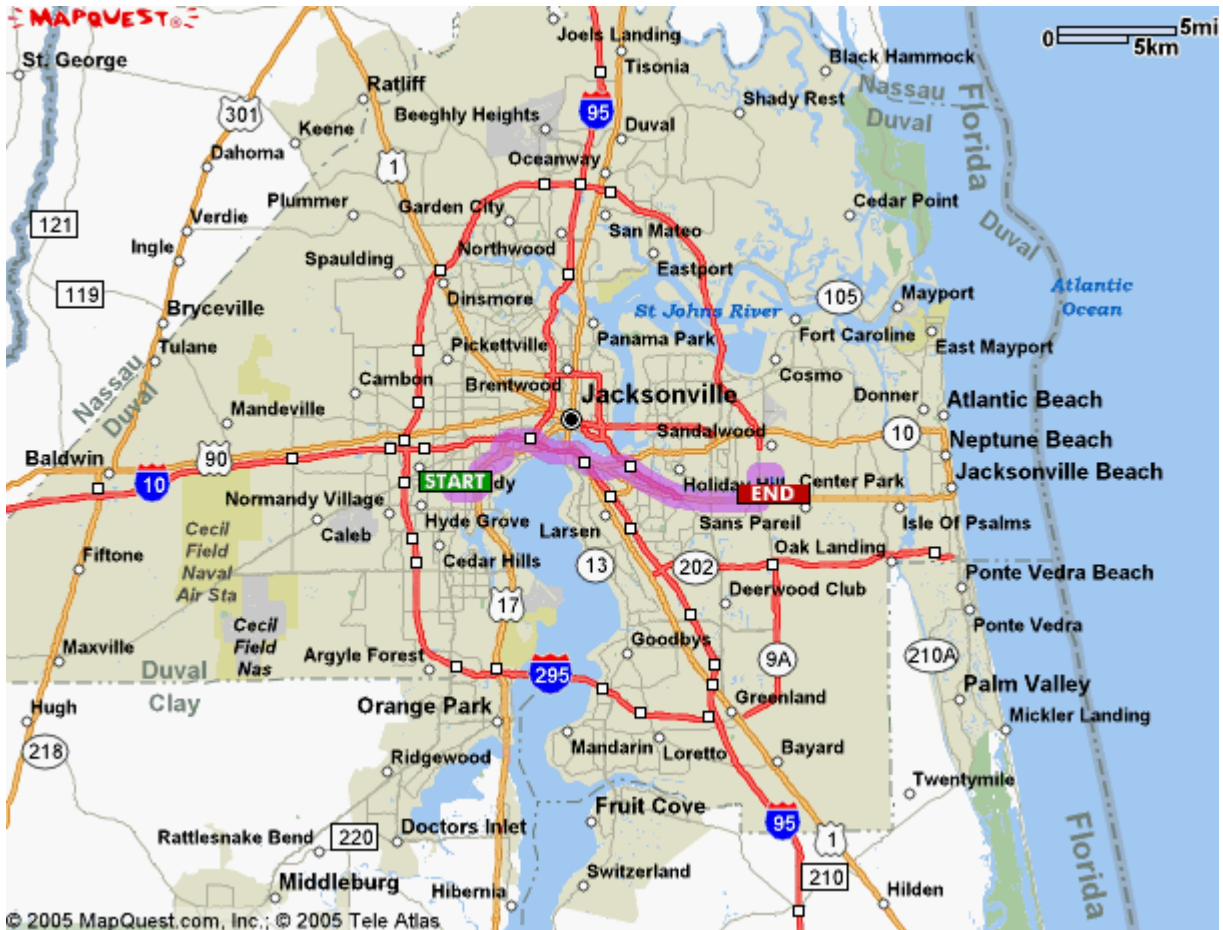

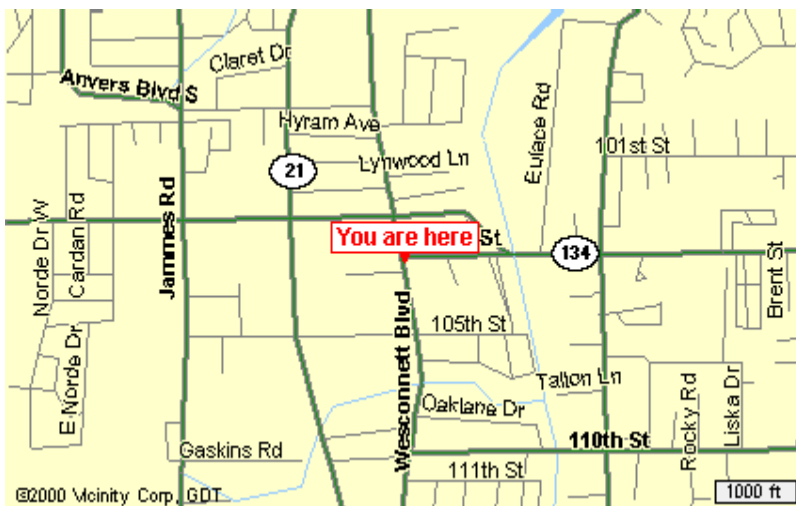
From I95 on the north side of Jacksonville, take the UNION ST. exit- EXIT 353B-toward

EAST US-90-ALT. Continue to follow W UNION ST. Merge onto US-90 ALT E / FL-10A E via the ramp on the LEFT toward ALLTEL STADIUM / MATHEWS BRIDGE.. Stay STRAIGHT to go onto FL-115 S / ARLINGTON EXPY. Continue to follow ARLINGTON EXPY. Turn SLIGHT LEFT onto ATLANTIC BLVD / FL-10 E. Turn RIGHT ONTO St Johns Bluff Rd. Turn left onto Alden Rd. Turn right onto John Prom Blvd.

From Baymeadows Rd., take 9A north. Then take St. John's Bluff Rd. south. Turn right onto Alden Rd. Turn right onto John Prom Blvd.

WESTSIDE FOOTBALL LEAGUE (WFL)

Take I295 south. Exit 103rd St heading right (east). (103rd Street will change to Timuquana once you have crossed over Blanding Blvd.) go to Wesconnett Blvd. and turn right (south) and the field is down on the right, across from the post office

2009 JUNIOR JAGUARS BOWL CONSENT FORM

Voluntary Medical Consent

In consideration of allowing my child to participate in the athletic and related activities of The Junior Jaguars Bowl, I _____ (parent/guardian), having actual knowledge, and conscious appreciation of the inherent and particular dangers involved in the participation in athletic and related activities, do voluntarily consent to my child's participation in the aforementioned activities and assume the risk arising therefrom.

I certify that my child has been examined by a physician and found to be in good health and able to participate in all activities without restriction.

Should routine first aid or emergency medical needs arise, I authorize representatives or agents of Jacksonville Jaguars, Ltd. (the Jaguars) to provide or consent to necessary treatment on my behalf. In the event that a major medical emergency or trauma requires treatment, I authorize representatives of the Jaguars to consent to such treatment of my child on my behalf and to obtain any emergency medical care that may become necessary in my absence. I understand that I will be responsible for the cost of any such treatment.

I hereby release and hold harmless any and all representatives, agents and employees of the Jacksonville Jaguars, Ltd. and all other promoters, sponsors, employees, volunteers and any others involved with The Junior Jaguars Bowl from and against any and all claims or liability arising from the provision of authorization for medical treatment to my child.

Photo/Video Release

I hereby authorize the Jacksonville Jaguars to make, reproduce, broadcast, sell, license and otherwise use photographs, films, videotapes, recordings or other depictions or images in whatever form or media of me and/or my child in connection with my child's participation in the event without compensation and for an indefinite period of time. Release and Assumption of Risk

I, on behalf of the MINOR, acknowledge and consciously appreciate that the activities inherently dangerous activities and that many injuries, including serious injuries involving paralysis and death, occur to people involved in such activities. Further, I assume full responsibility for any risk of bodily injury to or death of the MINOR, while the MINOR is a participant in The Junior Jaguars Bowl whether due to the negligence of the RELEASEES or otherwise.

I agree to indemnify the RELEASEES and to hold each of them harmless from and against any and all loss, liability, damage or cost RELEASEES may incur due to the participation of the MINOR in The Junior Jaguars Bowl, whether caused by the negligence of RELEASEES or otherwise.

I agree that this Consent, Release and Assumption of Risk is intended to be as broad and inclusive as permitted by the laws of the State of Florida and that if any portion of this agreement is held invalid, the balance shall continue in full force and effect.
